# The clock is ticking.

With the Midterms rapidly approaching, we face a critical closing window to shape the narrative. Public concern is extremely high, and the political will is emerging. What Americans desperately need is clear, credible, and accessible information before they cast their ballots.

We must act immediately to deploy our professional engine during this pivotal election cycle — as the opening phase of a disciplined 16-month national campaign.

**If we wait until after the Midterms, the political landscape will lock in against American freedom and sovereignty and our enemies will be emboldened and empowered for at least the next two years.**

# Sharia is not a private religious practice.

It is a comprehensive political-military-legal strategy for conquest pursued to subvert and replace our constitutionally guaranteed rights and government.

## Women and Girls

Under sharia, their bodily safety is imperiled and equal rights are gone.

## Freedoms of Speech and Religion

Under sharia, speech deemed to be blasphemy against Islam is a capital offense. And only Muslims enjoy religious liberty.

## Equal Justice Under Law

Under sharia, there is no equality between Muslims and Christians and Jews who are, at best, enslaved as “dhimmis” and forced to pay a tax to survive.

## Where sharia governs, the following are true:

- 1 Women can be sexually and physically abused with impunity.
- 2 Women do not have equal rights.
- 3 Women can be divorced and lose custody of children without due process.
- 4 Women can be compelled to cover their bodies.
- 5 Girls can be married off as early as six years old.

## PHASE 1: DEMONSTRATED PROOF OF CONCEPT

# A movement that can — and must — prevail.

Most Americans still lack clear, credible, accessible and actionable information about sharia. That information gap is the real battlefield. BanSharia.com's "Save Texas, Save America (STSA) Campaign" exists to close that gap at scale, with discipline and effect, mobilized in the defense of our Constitution and Republic.

# Digital Campaign OS + National Capabilities

BanSharia.com has evolved into a centralized platform that unifies original video and digital content production, intelligent multi-platform distribution, policy compliance, and supporter engagement.

### 1. Unified Campaign OS

One command center for research, production, policy review, and distribution.

### 2. Original Video Production Engine

Landscape (16:9) and mobile (9:16). Scaled to 15 information videos + 2 high-end viral videos per month.

### 3. Smart Platform Routing

Automated metadata tags trigger multi-platform publishing only after internal approval gates clear.

### 4. Category A / Category B Content

Intense unfiltered content → BanSharia, Rumble, X. Neutral educational hooks → Instagram, TikTok, YouTube Shorts, Facebook.

## Where the engine is applied. (A–B)



### Agile, Industrial-Scale Video Production

Generating a torrent of 90-second to 2-minute videos exposing the true nature of sharia. Low-cost team (15 videos/month) + High-end viral team (2 videos/month).



### Offensively Oriented Information Operations

Red Pegasus retained for strategic planning, social, digital, and PR amplification, plus tailored outreach: geo-fenced text-messaging, CCTV targeting, earned media, partner GOTV support, and conversational AI engagement.

## Where the engine is applied. (C–D)



### Campaign Partnerships

Mobilize America by initiating collaboration with Turning Point USA, pursuant to Charlie Kirk's final mandate to defend Western Civilization from Islam. Expand teaming with Moms for America, Moms for Liberty, AMAC, ACT for America, Faith and Freedom Coalition, America's Future, Faith Wins, Liberty Pastors, Citizens Defending Freedom, and National Association of Christian Lawmakers.



### Influencers + Legislator Education + OSINT + Training

Enlist prominent influencers; educational workshops and legal resources for legislators, including Sharia-Free America and Texas Caucuses; Valop Group fusion center, candidate vetting, and mapping of jihad's critical infrastructure; expand training.

## Where the capabilities are applied.

### **1. Sharia Is Not a Religion**

Develop the legal, constitutional, and religious case that while Islam is recognized as a religion, sharia is a foreign, totalitarian political-military-legal strategy for conquest. It is not entitled to First Amendment protection.

### **2. Candidates: For the Constitution or for Sharia?**

Press candidates to declare whether they support the U.S. Constitution as the supreme law of the land or believe it can coexist with sharia. Drive the “Sharia-Free Pledge” so voters can extract commitments and hold politicians accountable.

### **3. Enforce Governor Abbott’s Terrorist Designations**

Support enforcement of designations against Muslim Brotherhood and CAIR operatives, assets, and infrastructure in Texas. Work with Texas Public Policy Foundation and RAIR Foundation.

## Where the capabilities are applied.

### **4. Sharia-Adherent Muslims Cannot Faithfully Take the Oath of Office**

No sharia-adherent Muslim can truthfully take or execute an oath to support and defend the U.S. Constitution. Every sharia-supremacist candidate is ineligible; those already in office have committed perjury and must be removed.

### **5. Nigeria: Case Study of Violent Jihad & Warning to America**

The genocidal jihad against Christians in Nigeria is a prelude to a caliphate with global reach. STSA partners are preparing a powerful book and feature-length documentary.

### **6. Training to Counter Sharia**

Expand exponentially the reach of training programs for legislators, state and local officials, law enforcement, first-responders, intelligence personnel, and community leaders — especially in states where sharia is metastasizing.

# Two new phases. One continuous campaign.

### PHASE 2 — THE MIDTERM BLITZ (Months 1-3)

- Deploy architecture, video templates, routing rules, content inventory, and core rapid-response team
- Algorithmically flood key demographics with high-impact and retainable educational content
- Make the banning of sharia a voting issue nationwide
- Actualize Prop 10 momentum into Texas statutes and national awareness and action

### PHASE 3 — SUSTAINED ACCOUNTABILITY

- Hold newly elected officials to the commitments they made to voters
- Educate about model legislation to ban sharia in Texas and other states
- Sustain information operations, industrial-scale video production and open-source intelligence
- Expand training for officials, legislators, law enforcement and community leaders
